OVERVIEW

Welcome to Transatlantic Week 2022, our first in-person week since 2018!

The election of US President, Joe Biden, has injected momentum into the tasks of renewing and revitalizing the transatlantic partnership. EU/US leaders gathered at a landmark Summit in June 2021 “to renew our transatlantic partnership, set a Joint Transatlantic Agenda for the post-pandemic era, and commit to regular dialogue to take stock of progress. We are committed to uphold the rules-based international order.”

Since 24 February 2022, however, it has become clear that not all states now adhere to the rules-based order. Hallmarked by immense brutality and indiscriminate destruction of peoples’ lives, the Russian invasion of Ukraine has triggered the greatest migratory flow since World War II, creating in the process a new geopolitical reality.

The transatlantic partnership has quickly and effectively responded to a new threat to the security of Europe. The consequences are by no means fully apparent, but they are very likely to include greater unity of purpose and action. These are among the objectives to which both the EU (Strategic Compass adopted in March) and NATO (Strategic Concept adopted in June) are committed.

At the same time, new forms of transatlantic cooperation, strongly supported by TPN, are emerging across a broad field of endeavour. These add substance to the TPN Project “Towards Transatlantic Partnership 2030” and help to sharpen our focus on priorities, policies, and direction of travel.

This year’s Transatlantic Week will open in Washington DC on the evening of Monday 18th July and continue through Wednesday 20th July. A welcoming cocktail for all participants on the Monday evening will be followed by a broad debate on the geopolitical situation on Tuesday morning. Scrutiny of possible global trends to 2030 and beyond will be first, followed by a narrower focus on immediate challenges posed by Digital Transformation, Economy and Trade, and Sustainability.

The closing session will draw together ideas for fostering transatlantic partnership in the years ahead and nurturing a more developed transatlantic institutional framework. A stronger partnership will be an easier objective if there is consistent, attentive, and balanced involvement of political leaders across a broad range of policy areas.

Transatlantic Week 2022 will be an opportunity to review progress and successes to date, to define shorter-term priorities for action, and to recommit to longer-term partnership goals.

We would be delighted if you would join us in this search for ideas and help shape our future together! Priorities and recommendations defined at Transatlantic Week will be the building materials for our program activities in the months ahead on both sides of the Atlantic.

Russia's emergence as a hostile, militarily aggressive power in Europe, clearly moving into Beijing's orbit, poses difficult questions about the how the West should respond and organise itself. Is the world moving towards a system of regional political and economic blocs, (China + Russia and the US + Europe) heavily armed and permanently in competition for technological leadership and access to key mineral and food resources?

Strategic foresight is increasingly valued as an aid to governance. It promotes a holistic understanding of political, economic, social and technological dynamics, and hypothesises challenges and opportunities that lie ahead. In recent years, the European Strategy and Policy Analysis System (ESPAS) and the National Intelligence Council (NIC) in the US have each produced reports on global trends to 2030 and beyond. Is there potential for a strategic foresight alliance between the EU and the US?

The Trade and Technology Council is a specific initiative launched by the EU and the US in October 2021. Does the changing geopolitical context call for a change in JTA priorities, or are digital transformation and mitigation of climate change still top of the transatlantic agenda? What are the priorities for the year ahead?

The global digital economy risks fragmentation through the emergence of national digital rules, notably in China and Russia. Efforts are underway to secure the leadership of international bodies by countries with autocratic leaderships. The EU and US have made important progress to address common challenges with the Trade and Technology Council. Where does the policy dialogue between both partners stand today and what could be next steps? What role can the TTC play in addressing global challenges?

Potentially, transatlantic cooperation can expand and distribute to humankind the enormous benefits of transformative technological advances. Deeper forms of collaboration are also sought at a time when an agreed successor to the so-called “Privacy Shield” is to be applied to EU-US cross-border data transfers. For example, proposals for AI were raised at the recent TTC meeting in Paris. What needs to happen to ensure effective transatlantic collaboration for emerging technologies, such as AI, 5G and quantum computing? How can R&D cooperation be strengthened?

10:15 – 11:00 am How Will The EU And US Strengthen Resilience For The Transatlantic Economy While At The Same Time Promoting An Open Global Trading System?

It would be difficult to envisage a more “perfect storm” than the one currently gathering over the global economy. Post COVID economic recovery is being choked by inflation rates close to those of 40 years ago driven by the impacts of the Russia-Ukraine War and major hikes in demand and costs of energy, food, fertilisers, and other raw materials. Popular demand is building for more government supports and protection against inflationary increases.

Can and will the EU and the US stay true to their ambitious goals for digital transformation and decarbonised economies? Is there sufficient coordination of their approaches to fiscal and economic objectives?

Can the transatlantic partners maintain and promote multilateral rulemaking and liberal democratic values as essential frames for the global economy? What can be done to ensure the ongoing supply of critical raw materials and key inputs for a modern economy, like semiconductors? How can market distortions be avoided and third country barriers effectively challenged?

Critical shortages of energy, fertilisers and food that are fuelling current surging price rises are apparently unavoidable consequences of the Russia-Ukraine War. Transatlantic collaboration needs to avoid damaging competition for access to these resources that could aggravate supply chain shortages and push prices even higher.

How realistic is it to hope that we can speed up progress towards sustainable energy production and consumption, deliver transatlantic global carbon pricing leadership and manage short to medium term pressure on energy pricing in ways that protect the weakest in our societies? Will policies for sustainable agriculture continue to be seen as an opportunity for global protection against rampant climate change? Can we manage a looming crisis in global food supplies with a more open-minded approach to technology without undermining sustainability?

Business needs to partner government and be partnered by government in the quest for cutting edge technologies and the provision of goods and services that can satisfy popular needs. Many Western businesses are either closing or suspending operations and joint ventures in Russia. Does this suggest that the public now expects companies to demonstrate their adherence to humanitarian values and democratic processes?

3:30 – 4:30 pm Towards Transatlantic Partnership 2030: Priorities For Greater Transatlantic Resilience In 2023

TPN's mission is to promote a close Transatlantic Partnership by 2030 serving the goals of peace, security and the defence of democratic freedoms and human rights. Strategies for achieving the 2030 vision need radical alteration in the light of the extraordinary geopolitical changes triggered by the Russia-Ukraine War while the impacts are still being felt of technological transformation, global pandemic and supply chain fragility.

Policies have to be reviewed and rethought across a spectrum ranging from western defence and security, future relations with China and Russia to digital transformation and technology transfer.

Our discussions at Transatlantic Week 2022 are intended to help sharpen perceptions and understanding of current crises and to point to possible solutions, with the urgent need to consolidate. We expect that we will confirm the fundamental importance of Transatlantic partnership for securing global peace and indicate some useful avenues for carrying the partnership forward to 2024 and beyond to 2030. These might include:

- Working together on an evaluation of global trends to 2030 and beyond, assessing possible transatlantic policy responses that may be required;
- Highlighting the central importance of progressing towards the goals of the 2021 Joint Transatlantic Agenda and securing the opportunities for technological and regulatory advances through the work of the Trade and Technology Council;
- Recognising that the partnership needs to be underpinned by popular understanding, trust and consent that can be best achieved within an assembly framework of regular contacts, discussion and coordination between EU and US legislators;
- Formulating ideas which help set a new compass for the transatlantic partners to navigate through a turbulent environment provoked by wide-ranging geopolitical events. The need is to embed a future transatlantic relationship, driven by shared interests, within a broad partnership framework which will last for decades to come.
