**Tuesday, 2 April - Wednesday, 3 April 2024****"Challenges Ahead for EU-US Relations:  
Developing a Roadmap towards 2030"**

Dear Friends,

TPN held Transatlantic Week, for the first time in Brussels, from April 2 to April 3, 2024. The event was held in the Library of the European Parliament, similar to the Library of the US Congress being the place for previous Transatlantic Weeks in Washington, DC.

Participants were drawn from the European Parliament, the US Congress, the US Administration, and the European Commission, as well as the transatlantic business and academic communities. We warmly welcomed them all and were very grateful for their participation and ongoing support, without which the Week would not occur.

TPN always needs partners, participants, and a team. Once again, we had a great group of partners who not only provided support but also helped with preparatory work and the implementation. The Week would not have been possible without them. A huge thank you.

**Key takeaways from the Week were:**

- Given the commitment of TPN to involve the younger generation, it was rewarding to see steps taken to continue to build our Staffer Network, still with the aim of its full-time launch in January 2025. A special programme was organised for the US leadership component.
- The deepening of activity within the EU-US relationship shows no sign of abating, not least with wide-ranging cooperation underway on Ukraine. Our discussions revealed the broadening scope of the Trade & Technology Council (TTC), in particular on the sensitive question relating to AI. There is optimism that the Council could be developed to cover broader geopolitical and economic issues between the EU and the US.
- The progress made on our Transatlantic Vision 2030 exercise was welcomed, in particular, the conclusions of the Compass Project to fireproof the EU-US relationship updating the 1990 Transatlantic Declaration containing a series of proposals to make the EU-US platform more robust and inclusive. Exchanges began on priorities for the EU-US relationship for 2025 and beyond, starting the next phase of the exercise towards 2030 with a magnificent contribution from Ambassador Stu Eizenstat setting the scene, [which can be read here](#).

We are optimistic that our messages are beginning to be noticed. In its joint statement of 5 April, the Transatlantic Legislators Dialogue (TLD) supported the call for significant leadership initiatives to strengthen the EU-US relationship ([see full statement here](#)). Hopefully, this will be acted on at the next European Council in late June.

Now we are in the process of preparing the next phase of our 2030 Project. Please join our discussions throughout the rest of this year with a view to identifying priorities for joint action for the period 2025-2028 to incoming EU-US Administrations in December 2024. This will help the shaping of a roadmap to 2030.

And finally, a shout-out to the Team. For a small office, Transatlantic Week is a huge effort! I am sure that you will all join me in thanking the TPN Team – few of whom work for TPN but who come together to support TPN's mission and help make the Week happen.

**Session Summaries****Tuesday, April 2, 2024****Brussels****Session 1****Opening Comments**

The opening session comments of Transatlantic Week 2024 were given by TPN Chairman James Elles and Professor Danuta Huebner MEP.

The panellists acknowledged the strong foundation and achievements of the EU-US partnership, built on shared democratic values, economic ties, and cooperation on major global challenges like the Russia-Ukraine war, Middle East conflicts, and managing China's rise. Recent successes were highlighted, such as coordinated sanctions on Russia, support for Ukraine, and promoting democracy and human rights globally. However, there are also areas of friction, like diverging approaches to technology, privacy, and calls for European strategic autonomy.

The discussion concentrated on the influence of Artificial Intelligence (AI) on transatlantic relations and the effort to regulate this technology. It highlighted the European Union's proactive stance in AI regulation, contrasting it with a slower pace in the United States, and underscored the significance of collaboration to tackle the complexities AI presents. The conversation delved into the necessity for innovative legislative processes that accommodate rapid technological advancements and the importance of stakeholder engagement.

While some common frameworks exist, translating these into a cohesive transatlantic strategy remains an ongoing challenge, given the different threat perceptions and national interests involved. More substantive alignment is needed on developing positive economic incentives, addressing non-military arenas of U.S.-China rivalry, and achieving clarity on contingencies to secure continued coordination.

The session discussed the establishment and objectives of a transatlantic network for staffers from the United States and Europe, aiming to foster mutual education, policy debate, person-to-person networking, and the development of transatlantic leadership. This network, formed over the previous year, seeks to facilitate regular virtual meetings, with an aspiration for annual in-person gatherings to enhance dialogue and cooperation between staffers on both sides of the Atlantic.

The dialogue underscores the challenges and opportunities presented by rapid technological advancements, the need for agile and inclusive policy frameworks, and the importance of building trust and ensuring digital sovereignty in a globalized digital landscape.

Protected legacy industries may face tough transitions.
